It is the intention of the South African National Roads Agency Soc Ltd to establish various Quarries to provide the necessary construction materials for the proposed upgrading of national road R573-1 (K139) from Stormvoël Road in Tshwane (km 0,00) to the Gauteng / Mpumalanga Provincial Border (± 48.00 km). KBK Engineers appointed GA Environment on behalf of SANRAL to undertake an Environmental Authorisation Process for the proposed Quarry 6B. Overhead powerlines are situated at the north eastern boundary of the site, and along the north western boundary of the site. Both these powerlines intersect at a substation situated approximately 55 metres north of the study area at approximate coordinates 25° 37' 35.6"S 28° 16' 20.1"E. A part of the public participation process, GA Environment is required to notify the City of Tshwane Electricity department of the proposed development.

GA Environment (Pty) Ltd would like to inform you that the draft Scoping Report for the project has been compiled and is available for your review.

The 30 day legislated public review period commenced on the **20th of November 2020** and will end on the **18th of January 2021**. The report and appendices can be accessed using the following link.
