Thank you for providing GA Environment with your comments. The comments provided will be included in the Final Scoping Report for consideration by the Department of Mineral Resources and Energy. A response to your comments are provided below.

## **Haulage of Material**

Various haulage route options will be considered for the proposed Quarry. Haulage routes will include, the railway maintenance track towards the north of the site, Tamboti Road, Maroela Road, along the proposed PWV2 alignment (adjacent to the Kameeldrift police station) as well as additional internal road links. Public roads that will be used for the haulage of material will be maintained as needed during material production. Upon vacating the quarry sites, public roads that were used for haulage will be maintained one final time and left in an acceptable condition for public use. Haulage of material will be undertaken during the working daylight hours which excludes Sundays. Future Maroela Road upgrades (extent is yet to be determined) and realignment is planned in order to align the road and urban interchange with future road networks will likely commence in 2023.
