Notice is hereby given in terms of Chapter 5 of the National Environmental Management Act (NEMA) (Act No. 107 of 1998) and Chapter 6 of the NEMA Environmental Impact Assessment Regulations (EIA), 2014 (as amended), that Harmony Gold Mining Company (Harmony) is proposing to construct a new slurry and return water pipeline at its Allanridge Target Plant Operations from its TGT 2 Tailings Storage Facility (TSF) to Freddie's 9 TSF. The Target's TSF 1 and 2 have reached their final design height or become unserviceable and therefore a pipeline must be built to connect the Target TSF to Freddies 9 TSF. This Notice is also in terms of Section 41(4) of the National Water Act No 36 of 1998, read with Regulations 17 to 19, regarding procedural requirements for Water Use Licence Applications and Appeals in GNR 267, published in Government Gazette 40713 of 24 March 2017. In line with the NEMA EIA regulations, Harmony has appointed GA Environment (Pty) Ltd as the Independent Environmental Assessment Practitioners to undertake the Basic Assessment (BA) and Water Use Authorization (WUA) Process for the proposed development.

The proposed slurry pipeline (5.6km) will have a diameter of 300mm and an average flow rate of 93 litres per second (ℓ /s) and starts from TGT 2 TSF to the Freddies 9 TSF. The proposed return water pipeline (8.3km) starts from Freddies 9 Return Water Dam (RWD) with coordinates 27°50'31.66"S and 26°40'32.30" and heads northwest to immediately northeast of TGT 2 TSF with coordinates 27°47'32.23"S and 26°38'20.25"E where it is connected to the existing pipelines towards the Target Plant. The return water pipe will have a diameter of 200mm and an average flow rate of 40 ℓ/s. The two pipelines will be installed parallel to each other along the proposed route. One pipeline will transport return water from Freddies return water dam (RWD) and the other pipeline tailings from Target Plant to Freddies TSF. The pipeline will be a flanged steel pipeline installed above-ground on pre-cast concrete plinths and will cross underneath the R30 road through a culvert. A 3.5m wide access road, adjacent to the pipelines, will be cleared/graded to provide access for construction, maintenance and inspections.

According to the NEMA EIA Regulations 2014, as amended, a Basic Assessment (BA) is required for the project based on the following triggered activities: Listing Notice 1 Activity 12, Activity 30, and Listing Notice 3 Activity 12 and Activity 14. The pipeline is located within the regulated area of identified watercourses and a Water Use Authorization (WUA) will be triggered in terms of Section 21 (c) and (i) of the National Water Act (NWA), 1998 (Act No. 36 of 1998). The applicable water uses will be confirmed by the Department of Human Settlements, Water and Sanitation.

In terms of the NEMA EIA Regulations, 2014, as amended, and the Regulations regarding the Procedural Requirements for Water Use License Applications and Appeals (2017), all Interested and Affected Parties (I&APs) must be provided with an opportunity to participate in the BA and WUA Process for the proposed project.
